9. mosarCelem gaerTianebuli samefos sazRvari gadmokveTa 1998 wlis 28 marts yalbi saxeliT. igi seriozulad gaxldaT avad da miyvanil iqna saavadmyofoSi, sadac diagozad daudgines aiv dedebiToba, romelsac Tan axlda "mniSvnellovani imunodaqveiTeba da ... gavrcelebuli mikobaqteriuli tuberkuliozi".
10. 1998 wlis 31 marts iuristembma misi saxeliT Seitanes gancxadeba TavSesafris maZieblobaze, acadebdnen ra, rom ugandis erovnuli winaaRmdegobis moZraoba (National Resistance Movement) mas sastikad epyroboda da rom maT mosarCele mxolod imis gamo gaaupatiures, rom asocirebuli iyo xelisuflebis winaRmdegobis
